# MEMORANDUM OF UNDERSTANDING (MoU)

## **CLAUSE 1**

## CO-OPERATION

- 2.2 Guest Lectures: Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in-house requirements.
- 2.3 Placement of trained students: the second party will actively engage to help the delivery of the training and placement of the students of the first party on the technology trends and in-house requirements.

- 2.4 There is no financial commitment on the part of the **Eshan College of Engineering Farah**, **Mathura**, the first party to take up any program mention in MoU. If there is any financial consideration, it will be dealt with separately.
