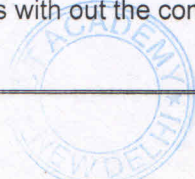
3 Role of ESHAN COLLEGE

12 GOVERNING LAW:

This MOU is made under and shall be governed by and construed under the laws of the Republic of India under the jurisdiction of the courts at Delhi.
