Subject: Regarding the Provisional Affiliation of the academic session 2019-20.

Sir/Madam,

With regard to the above subject, I am directed to inform that on the basis of the recognition given to your institution by the All India Council of Technical Education, New Delhi for the session 2019-20, after consideration by the University Affiliation Committee / Affiliation Review Committee of UP Government Recommendations made and in accordance with these recommendations Government Order No. 1538/16-1-2019-13(1)/2018 dated 15.05.2019 promulgated in the University under Section 23(2) of the Uttar Pradesh Technical University Act, 2000. Pending the approval of the Executive Council, the Institute is to offer courses with intake capacity as under:

Under the self-financed scheme, the temporary affiliation is approved by the university for the academic session 2019-20. The above temporary affiliation is subject to the following:-

- 1. Institute by All India Council of Technical Education New Delhi / Dr. APJ Abdul Kalam Technical University earmarked land Building, infrastructure facilities, equipment prescribed for teaching-learning curriculum, laboratory prescribed for the course, faculty ratio, prevention of ragging and it will be mandatory to fulfill the norms/standards shown in the inspection of the institution by the inspection board of the university, otherwise the temporary affiliation given to the institution will automatically be deemed to be cancelled, for which the entire responsibility will be of the institution/management itself.
- 2. Along with the verification of infrastructure facilities and adjusted teachers by the inspection board, the audit of the accounts of the institute can also be done by the university at any time.
- 3. The institutions running the courses of B. Pharma / M. Pharma / B. Arch / M. Arch Ptermacy Council of India and

Council of Architecture of fulfillment of prescribed standards for conducting courses and also obtaining approval for session specific from the concerned council will be mandatory. In case of non-fulfilment of the standards set by the Institute and PCI / COA (as applicable). In case of taking admission in excess of the permissible admission capacity, the temporary affiliation given by the university to the institute will automatically be deemed to be cancelled whose entire responsibility will be of the institute/management itself.

- 4. The institute will ensure compliance of the guidelines issued from time to time by the Department of Technical Education, Government of Uttar Pradesh / Dr.A.P.J. Abdul Kalam Technical University, U.P. and institute will take only the permissible admission fees as per the guidelines. Along with this, the institute will make timely availability of the information to them government / university related to teaching-training. If the institute fails in the above requirements, action will be taken to reduce the privileges related to affiliation or cancel the affiliation.
- 5. After getting the affiliation of the institution, if any kind of error in the number of seats and non-deposit of fees related to the information/details given by the institution at the time of online application comes to the notice of the Government University, then the provisional affiliation will automatically be deemed to be cancelled, for which the entire responsibility will be of the institute itself.
- 6. The compliance of the provisions mentioned in the Chapter 6 (Affiliation) of the first Regulation of Higher Technical University 2010 promulgated in the university will be ensured by the institution, otherwise action will be taken to terminate the affiliation.
- 7. The institute will complete the appointment of prescribed qualification holder teacher and director/principal in the required number according to the standards of the regulatory body in relation to the permissible admission capacity by the regulatory bodies before August 01, 2018. Along with this, all records related to the list and selection of these teachers will be submitted to the university and a notarized affidavit will have to be given to the effect that the required number of teachers have been appointed by them as per rules. In their independent verification by the University, if any error, forgery/discrepancy is found, then the temporary affiliation granted to the institution will automatically be deemed to be cancelled, for which the entire responsibility will be of the institution itself.
- 8. After the commencement of the session, if the post of Director/Principal of the institution becomes vacant, then from the date of vacancy, the process of selection should be completed within three months and appointed on the vacant post, which must be informed to the university (Chapter 6.15).
- 9. After the commencement of the session, in the event of the teachers working in the institution leaving the institution, within 15 days (working days) Must Inform to the university. (Chapter 6.18).
- 10. The salary of teaching and non-teaching staff will be drawn regularly, otherwise the university will initiate action in accordance with the rules and regulations. (Chapter 6.25B)
- 11. Complete details of Lab and its equipments should be displayed on the notice board website of the organization and its information must also be given to the university. (Chapter 6.13)
- 12. All the information of the institution should be displayed on the website of the institution and its information must be informed to the university as well (Chapter 6.16)
- 13. The information about the fees charged by the institution from the students will be displayed by the institution on its website and on the notice board of the institution. Its information will be made available to the university, otherwise appropriate action may be taken against the institution.
- 14. In case of termination or cancellation or withdrawal of recognition of All India Council of Technical Education, this affiliation will be automatically cancelled.
- 15. Institutions associated with the teaching and training of the disciplines of Pharmacy and Architecture, for all the courses of these Visas, the related business regulatory organization Pharmacy Council of India / Architecture Council of India (as applicable) called for recognition permission for the session 2019-20. must be made available to the University before the counseling of the State Entrance Examination to be conducted. In the case of not getting all the courses of Pharmacy and Architecture, the institute will not be able to give attricts to any new student in

the session 2019-20 in a particular course, neither through counseling nor on its own level directly on the vacant seat or management fault, the institute itself will be responsible for these circumstances.

- 16. The surprise inspection of the institute can be done by the university at any time during the academic session and in the said surprise inspection in view of deficiencies related to the prescribed standards, action can be taken to terminate the affiliation.
- 17. In respect of institutes and university standards, any inspection or investigation is done by the government or university level or any notice is issued, then the affiliation of the concerned institutes will be subject to action.
- 18. In addition to the admission standards set by the University and any other type of fee from SC / ST students in addition to the admission standards set by the University in Uttar Pradesh Educational Institutions (Reservation for Scheduled Castes / Scheduled Tribes and Other Backward Classes) Act, 2006, in admission by the institution, any other type of fee Action will be taken to terminate the affiliation in case of non-compliance of the arrangements of the mandate of the state government.
- 19. Regarding the fee reimbursement for the students of 18 different categories, the government orders / orders issued from time to time by the government / university Compliance will be ensured by the Institute. If these orders are disobeyed by the institution, in that case their affiliation termination action will be taken.
- 20. It should be ensured by the institute that the newly admitted / studying students in the institute are charged the same fee which has been determined by the fee fixation committee. University on complaint of taking any other kind of fee / donation and action will be taken to cancel the affiliation of the institution and blacklist the institution.
- 21. In respect of AMS (Academic Monitoring System), the circular no. UPTU/R.O./2014/4414—21 dated 11.07.2014 issued by the University shall be compulsorily followed.
- 22. Regarding the responsibilities given by the university to the teachers and non-teaching staff of the institute for academic and examination work, It will be the responsibility of the institute to ensure to get the work done. It shall be the responsibility of the institution that it shall not appoint teaching or non-teaching staff will make sure to get the work done. If this is not possible due to certain reasons, then the institution must obtain approval from the university. 23 Affiliation of a certain percentage of approved admission capacity of certain institutions postponed for session 2019-20 due to less number of students registered in courses in the last academic session, less number of available teachers than required number as per standard and less examination results of registered students is placed. Before issuing the affiliation for the upcoming session 2020-21, the revival or modification of these will be reviewed
- 24 The pending capacity of affiliation of a particular course can be calculated by deducting the value of column 6 in column 4 or 5 (as applicable) of the table of affiliation details.

In case of deviation in the compliance of the above mentioned conditions or any shortcomings are found in the surprise inspection of the institution, the temporary association of the institution will automatically be deemed to be cancelled, for which the entire responsibility will be of the institution/management itself.
